Some Co Counsel staff rec'd memo from an Assistant Deputy CoCo notifying our members that they cannot honor UPE's labor action (i.e. not cross the picket line) without ramifications (hence the letter from BC&Mc to Co Counsel 033 members.) Kelsey will ask Jason to write a similar letter for 032 members. Craig said he'd post it on the website and e-mail to members as soon as it was received.
